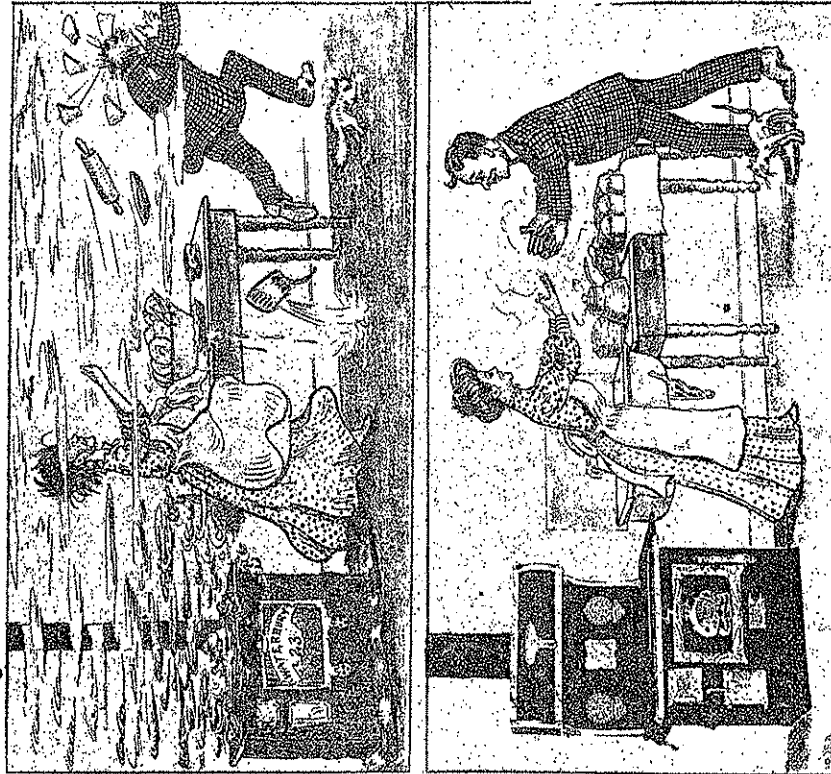

## Rules and Regulations on Local, Long Distance and Creek Lines.

### MEMORANDUM.

1. CENTRAL ONE LONG RING.
2. Time for each message, three minutes or any fraction thereof. Extra charges for overtime.
3. 50 CENTS EXTRA will be charged for all messages delivered, or for any person having to be brought to the telephone at any station on the line.
4. Station Masters or Subscribers shall collect in advance before allowing any person to use the Telephone, and they shall be held responsible for the payment of all messages sent through their Telephone.
5. Station masters shall hold all messages strictly confidential and under no circumstances repeat them except to the person they are directed to.
6. Station Masters shall not answer any ring but their own, nor shall they open their Phones while other persons are talking over the line. And in no case shall they allow any Stranger to answer their ring.
7. Station Masters shall not be allowed to talk over the line to each other without charge. No person shall be allowed to talk over the line free of charge unless he shall present to the Station Master an order signed by the General Manager of the Company.
8. Any deviation from the above Rules and Regulations will not be tolerated by the Company, and any Station Master discovered breaking said rules shall forfeit the right to the Telephone at their station, and the same shall be removed.
9. The Company reserves the right to remove Telephones at any time it desires to do so.
10. No liability shall attach to the Company for interruption of service from any cause.
