F. Noyes, Probate Judge. This is to certify that by authority of a license under the seal of the Probate Court of said county, Mr. George W. Passel and Miss Martha A. Jones were by me on the 25th day of June in the year of our Lord One Thousand Eight Hundred and Sixty Seven, legally united a husband and wife. Signed: J.D. Photocopy of Certificate of Marriage: This is to Certify, that by Authority of a license issued by the Judge of Probate Court of said County, Mr. John C. Saunders and Miss Sylvia Panzer were by me legally united as husband and wife on the 15th day of July in the year of our Lord Nineteen Hundred and 33. Signed: Henry C. Rogers, and witnesses: ?zel S. Gebhart and ?ut R. Panzer Jr.

Photocopy of Marriage License as follows: The State of Ohio, Hamilton County No. 137, Be It Known, That License and Permission of Marriage are hereby granted unto Robert R. Panzer and Anna W. Passel And any Minister of the Gospel, Justice of the Peace, or other person legally licensed to solemnize Marriages, is hereby authorized to join them in Marriage, according to law. In Testimony Whereof, I have hereunto set my hand and affixed the Seal of the Probate Court, at Cincinnati, this 26th day of Oct. A.D. 1904. Signed: Chas F. For Convenience of Government Said John SAUNDERS was born August 1st 1895 at Middletown, Ohio, and when enlisted was 67 inches high, with Gray eyes, Auburn hair, Ruddy complexion; occupation, Draftsman; citizenship, U.S. Accepted for enlistment at R.S., Dayton, Ohio. Given under my hand and delivered at M.B., Paris Island, S.C. this 9th day of April 1919.
