#### Law requires cemetery operators to keep records

Even in death, Indiana citizens are protected - by a comprehensive cemetery law (Indiana Code, Title 23, Chapter 14). One of the most important features is the record-keeping requirement that all cemeteries, whether they're privately or publicly operated, have to maintain. The cemetery operator must keep a record of who was buried and where they were buried. They also have to keep a record of who has purchased the cemetery plots, noted Bob Kraft, of the Indiana F.B. Legislative Dept.

If you are looking for an ancestor and have a general idea of the burial site, you can ask for burial records and the exact location of the grave.

**Philip Brown  
and  
His Descendants**

My research has not been extensive on my great-great-grandfather, Philip Brown. However, I have written down the few things that I have collected over the years, things that I have read about him, and also what my ancestors, aunts and uncles have told me about him. It is not known when or where Philip was born. Family tradition says he was born and reared "in the South".

The first accurate record I found was his marriage 25 March 1818 in Chillicote, Ross County, Ohio, to Julie A. Taylor. In 1821 he and his wife were living in Centerville, Wayne Co., IN, where their daughter Mary Ann (my great grandmother) was born. It seems that in the next few years they moved back and forth between Randolph and Jay Counties in IN.

Philip died 26 Feb 1863 near Deerfield, IN, and is buried near there. I have searched many cemeteries around Deerfield, but have not been able to locate his grave in any of them. Perhaps he and his wife lie in unmarked graves.

The thirteen children of Philip Brown & Julie Taylor were:

1. Mary Ann Brown, married Charles Alberson
2. An un-named daughter died in infancy and was buried near the road along the bank of The Little Salamonia River in Wayne twp., Jay Co., IN.
3. Oren Brown, burned to death quite young as a result of tipping hot soap over on him while his mother was making soap with lye.
4. A son (name unknown), died with "blacktounge"
5. Effa Brown (twin), married Henry H. Cossirt.
6. Zeffie Brown (twin), died young.
7. Eva Brown
8. Sarah Ann Brown, married William Emery
9. Philip Brown, shot himself one Sunday morning while the rest of the family was at Church. He was between 14 & 16 yrs. old.
10. Hester Brown, beleive she died at Richmond, IN. Unmcd.
11. Jacob Brown, 1/m Elizabeth Doty, 2/m Sarah Jane Holloway, 3/m Melvina Davis White. He was a Civil War Vet.
12. Fannie Brown, died when she was 13 or 14 yrs. old from scarlet fever. She is buried in the Alberson Cem. Adams Co., IN.
13. George Brown.

On page 75 of the Jay County History was recorded the 1st death in Jay County.

" Mr. Winters made the coffins in those days. Therebeing no lumber for the purpose, punheons were split out of logs hewed and planed until they looked as well as sawed lumber. In such a coffin a child of Philip Brown was buried on the north bank of the Little Salimonie, near the road. That was the first death in Wayne twp., Jay Co., IN".

After reading the many stories about my ancestor Philip Brown, I wondered did he really enter his land according to law or was it just "another story" that had been told about him. I wrote to the National Archives in Washington, D. C. to find out. In a few weeks I received a copy of the following:

**No. 1975 Land Office, Fort Wayne, Indiana 28 Mar 1833**

It is hereby Certified, that, in pursuance of law, Philip Brown of Randolph County, Ind. on the day purchased of the Register of this Office, the lot or South West quarter of South West quarter of section number 28 in township number 23 (Northh) of range number 14 (East) containing 40 acres, at the rate of one dollar and twenty five cents peracre, amounting to fifty dollars, for which the said Philip Brown has made payment in full as required by law.

Now therefore be it known, that, on presentation of this certificate to the General Land Office, the said Philip Brown shall be entitled to receive a patent for the lot above described. Signed---R. Brackenridge, Register.

The land patent was recorded 5 Aug 1834 Vol. 4 pp 439

At the same time Philip also swore to the following statement: "I do solemnly swear that the tract of land within described is inter. ! for my own personal benefit and not in trust for another and that the land is intended for the pupose of cultivation".

Philip was a great pioneer and it seems that he was also a man of much spirit as was found in the book "REMINISCENCES OF ADAMS, JAY AND RANDOLPH COUNTIES". This book was published and sold to raise money to put a fence around what is now known as the Gravel Hill Cemetery in Jay County, east of Bryant, IN. The land had been donated by Samuel Alberson, brother of Charles Alberson, who later became the husband of Mary Ann Brown. The book consisted of stories that many people had sent to the author to be included in the book. Many stories were also found in the history books of Jay County IN. The stories were very interesting and sometimes even amusing. So, in order for you to learn more about the pioneer life and your ancestor Philip Brown, I am including some of the stories as they appeared in the above mentioned books.

On page 70 - "Mr. John James, of Randolph County, was one of the commissioners to lay out the State Road from Richmond to Fort Wayne, and Jer. Smith was his Surveyor. In September 1832 while making a survey, they camped on the north side of the Little Salimonie, where the road now crosses it, probably attracted by the beautiful grove, which is now owned by Mr. JonasVotaw. Here they were visited by Philip Brown, of whom they obtained "roasting ear" and squashes. They called him "Govenor of the State of Salimonie", which cognomen he wore while he lived".

Whenever he makes a speech he also has handouts explaining military markings you might find on tombstones while doing research.)

## Civil War Unit Designations

**Federals** - Also known as Yankees

**Inf** - Infantry, can also be mounted

**Cav** - Cavalry, can be mounted or dismounted

**Art** - Artillery, can be light or heavy

**Eng** - Engineers, road builders, telegraph lines or trains

**Reg't** - Regiment, part of division comprising several companies

**Troop** - Same as company, only mounted

**EMM** - Enrolled Missouri militia, organized unit

**Prov EMM** - Provisional EMM, Reserves of EMM, on call

**Vol** - Volunteers, not drafted

**VV** - Veteran volunteer, serving 2nd or 3rd hitch

**Galv** - Galvanized-Confederate POWs who served in Federal blue on Western Plains fighting Indians

**MHGRC** - Missouri Home Guard Reserve Corp

**USCT** - U.S. Colored troops, all black in the ranks led by white officers

**AC or AD** - African corps or African descent. Black units from Louisiana, Mississippi or Alabama

**SC** - Signal Corps

**Med Co or MC** - Medical Corps

**VRC** - Veteran Reserve Corp

**Confederates** - Also called Rebels, Secessionists, Secesh's

## Courthouse records listed

In doing genealogy research, there is often the need to write to courthouses for copies of original documents. One of the best sources we have found for doing this is *The Handy Book for Genealogists* by Everton Publishers of Logan, UT. It has gone through eight editions with the ninth to be released soon.

The book is arranged alphabetically by state. Each section starts off with a brief history of the settlement of the state and the availability of vital records at the state level. This is followed by a list of archives, libraries and societies in the state and a list of many of the printed sources on the state.

### **Incorporation Of Keystone, Indiana**

The entries below were copied from a ledger book of meetings for the Incorporation of the Town of Keystone, Indiana. It also contains the yearly Treasurer's reports from the year 1898 to 1908. Grafton Luther Kean (my great grandfather) was born 1848 in Randolph County, Indiana and came to Wells County, Indiana in the fall of 1872 with his father, Dr. Raford Wesley Kean (my great-great grandfather, and also great-great grandfather to Virginia Wittwer). They settled one mile north of Keystone. Grafton moved to Keystone, and was elected to serve as Treasure, beginning in 1902.

#### **Keystone, Ind.**

**Dec. 6, 1895**

Minutes of Incorporation meeting held Friday evening Dec. 6, 1895. The house was called to order and the announcements made. Mr. Jno. Bell moved that Wm Twibell should act as chairman for the election which was held the next following day and was elected by all votes present. J. S. Neff was appointed clerk which was carried and Henry Cottril was elected judge and Henry DeWitt Sheriff on Saturday Dec. 7, 1895. The election board met and held their appointed places at the Keystone School house there was on that day Twenty nine (29) votes cast and they were all cast in favor of incorporation. The chairman Wm Twibell took the returns to Bluffton town Monday Dec. 9, 1895 and laid the same before the commissioners of this county to be enacted upon and they decided the town of Keystone Wells County State of Indiana was Incorporated.

#### **Election Report**

Mr Wm Speaker and Jos Gustin were sworn and qualified this 21<sup>st</sup> day of Dec. 1895 to fill the vacancy of Wm Twibell and Henry DeWitt. Wm Twibell disqualified in filling his chair as before on account of being a candidate in first ward. Henry DeWitt being absent we deemed our duty to appoint the said parties to fill the place.

The town council of Keystone met with all the councilman present. On ballot Wm Twibell was chosen president of the council of the incorporated town of Keystone the bond of Treasure and Clerk were presented and accepted by the council. It was agreed that the regular meeting night shall be two weeks apart on Monday night commencing Feb. 3, 1896. Council then adjourned to meet Feb. 3, 1896.

Be it remembered that the board of Trustees of the town of Keystone met in regular session and transacted the following business to witt: Meeting called to order by the chairman and the Trustees all present. By laws as per recordered on page one in ordinance Book were read and adopted. That the ordinance for construction of side walks were discussed, read, passed, adopted and ordained. The council then adjourned to meet in regular session Feb. 17, 1896.

That the ordinance for prohibiting Nitroglycerene to be taken within the limits of the Incorporated town of Keystone was passed adopted and ordained. Council then adjourned to meet in regular Session Mar. 2, 1896.

Be it remembered that the board of Trustees of the town of Keystone met in regular session and the following business was Transacted. The council was called to order by the chairman and all the councilman present. The minutes of the previous meeting were read and approved. The town seal was received Mar. 16, 1896. No. 5 in the order of business in regard to the disposal of a dead hog in the stock pens agreed to pass an ordinance to abate all nuisances a proposition to consider the election of a marshal also the by laws be amended to state what the town seal shall be. The sidewalks on Clay street was considered in regard to their construction agreed to consult parties directly interested in the matter in the above construction. A discussion followed on the construction of side walks for streets and alleys. It was ordered by the town board that the town clerk to correspond with D. S. Hill, Gen. Supt. in regard to the construction of sidewalks. No further business to transact the council adjourned to meet in regular Session Mar. 30/96.

The Town board of Trustees met in regular session with all the councilman present with the exception of J. B. Bright, and transacted the following business. The minutes of the previous meeting were made and adopted proposition for abatement of obstruction of an alley 150 feet north of Market street the above matter was considered the council agreed to notify parties interested. An ordinance declaring what shall constitute a nuisance and a penalty for the violation of the mode of abating the same and declaring an emergency was considered passed. Adopted and ordained by councilman Twibell and Teagle. J. B. Bright was absent this 30<sup>th</sup> Day of March 1896. No further business to transact the council adjourned to meet in regular session Apr. 13, 1896.

The proposition in regard to moving an obstruction on an alley 150 ft north of Market Street decided to wait until another meeting. The council had a discussion in regard to purchasing lumber for sidewalk purposes crossing Streets and Alleys. Council adjourned to meet Apr. 27, 1896.

Be it remembered that the town council of Keystone met in regular session with all councilman present except J. B. Bright and the following business was transacted. The minutes of previous meeting were read and adopted. The proposition to consider the number of days to work privilage tax it was decided that each able bodied male person between the age of 21 years and 50 years shall work three days on the streets and that teams will be allowed at the rate of (\$2.50) two and 50/100 dollars per day and hands (\$1.25) one and 25/100 per day. Council then adjourned to meet in regular session May 11, 1896.

Said lease was granted. No further business to transact council adjourned to meet in regular session May 11, 1896.

The town clerk be paid him in the sum of two & 50/100 Dollars per month this was taken under advisement a proposition considering the tax of the town was discussed and continued until further meeting. A petition for an abatement of a nuisance of oil and mineral water in a certain ditch in south end of town be abated the petition was accepted and council agreed to notify the Centiliver Oil Co. to abate said nuisance. No further business to transact council adjourned to meet in special session May 19, 1896.

Ordinance passed adopted and ordained by all councilman Twibell, Marsh and Wilson. The council also agreed to levy a tax \$.25 on one
