Will of **JAMES LATTA**, 22 Mar 1832, prb
28 Oct 1839 [not recorded in the will books but in
the county court minutes, Book 8, pages 418-420.]

Being advanced in years but of sound mind, it is
my will that my executor pay all my just debts and
funeral expenses. I will to my beloved wife **Jane**
during her life the Negro **Suckey**, a horse, two beds
& furniture, several specific items of household
furniture, the proceeds of 100 shares in the Union
Bank of Charleston, SC, and at her death she may
dispose of \$2,000 from these shares.

I will to **James G. Torrence** \$2,000 to be paid
to him six months after my death. I will to my
daughter **Elizabeth L. Davidson** the Negro **Peter**
and \$2,096 in cash. I will to my son-in-law **Rufus**
Reed \$3,113 to be paid six months after my death. I
will the following Negroes **Ned, Darkey, Patsey,**
Levi, Moses, Charley, Aimey, Cato, Tarn, &
George, and all my farming tools, household &
kitchen furniture not devised to my wife. My bank
stocks are to be divided into three shares, one I will
to my son-in-law, Rufus Reed, one to my son **Robert**
Latta, and the other third to be equally divided
among **Robert, John, James, William, Joseph, &**
Benjamin, sons of Elizabeth L. Davidson.

At my death my executors are to sell the Dunn
place, the Prim, Moore, Henderson, & home tracts,
and the fishing place, and the proceeds divided into
three shares, one to my son-in-law Rufus Reed, one
to my son Robert Latta, and the other share divided
among my grandchildren, the sons of Elizabeth L.
Davidson. The remainder of my property not
heretofore devised is to be sold and the proceeds
divided among Elizabeth L. Davidson, Rufus Reed,
and my son Robert Latta. I nominate as my executor
my son Robert Latta. Wit: John H. Davidson & W.
Morrison.

Codicil, 24 July 1832: I give to my grandson
William Torrence and my granddaughter **Jane**
Torrence \$2,000 to be equally divided between them
six months after my death. I revoke the sum of the
same amount willed to **James G. Torrence**. Wit:
John H. Davidson & A. B. Davidson.
