

Index of *Old Settlers' Edition of Athens Review*, published August 2, 1901

The *Old Settler's Edition* of the *Athens Review* is a historically important 10 page publication devoted to early residents of Athens and Henderson County from the mid 1850s forward. Some of the content is also devoted to activities in 1901 and as such, many of the names in this index are related to activities of 1901.

(Note - Old Settler's who are profiled in the edition are identified by the word "profile" in bold. Those whose names appear more than once on a page are shown with the page and the number of occurrences in parentheses. Only if the name identification callout line was identical did the compiler list multiple pages for an entry. This compiler also identified those mentioned in the edition as having served in the Civil War. It is quite likely that several others on this list served in addition to the ones noted.)
