

Nominating Committee

The Nominating Committee is a standing committee of five members: the VP, the Director of Membership, and three members who are elected from the membership at the Annual Meeting. The Nominating Committee selects a chair by mutual consent and submits at least one candidate for President, VP, Secretary, Treasurer, and three Nominating Committee positions. The slate is announced at the May general meeting for elections at the Annual Meeting in June. Additional nominations may be made from the floor if the candidate agrees to serve. Members of Nominating Committees hold their positions until replaced by successors filling vacancies should any occur during the year.

The committee may first choose to ask the Board members if they would like to continue or, perhaps, take another position; this is an efficient way of helping the Board fill any vacancies (sample e-mail):

I'm contacting you on behalf of the Nominating Committee for the Genealogical Society of South Whidbey Island. We are tasked with finding candidates by May __ for four elected offices: President, Vice President, Secretary, and Treasurer. We also will need to find three non-board members to serve on the next Nominating Standing Committee.

In the interest of getting a head start for the Nominating Committee, I'd like to ask you (semi-officially) if you'd be willing to continue serving the GSSWI as _____. We'd be delighted to have you continue.

If for some reason you were unable to continue, is there someone you might suggest to take over your job? Would there be another position that you'd consider taking next year? The positions we would like to fill are _____.

It is helpful and efficient for the Nominating Committee to ask about other possible vacated positions someone may be willing to fill while they are speaking to them. The following is a list of our GSSWI positions:

Seven elected positions:

President, Vice President, Secretary, Treasurer, and 3 Nominating Committee positions.

Nine director positions:

Archives, Education, Field Trips, Library, Memberships, Programs, Publications, Publicity, and Volunteers.

Three Audit Committee positions.

Several Ad Hoc Committee positions:

Door Prizes, Greeter Coordinator, Island Research Outreach, Printer Custodian, Projector Custodian, Seminar (every other year), Videographer, and Website Manager.
